Prior to making significant changes in a residency training program, approval of the ACVIM and LAIM RTCC must be obtained. The candidate and/or program director must notify ACVIM, in writing. Significant changes could include, but are not limited to: changes in Program Director or any advisors, transferring from one program to another, alterations in program duration, switching to a ‘dual board’ program, or enrolling in an institutional graduate program.

Notice: This form contains questions for three separate purposes; data collection that ACVIM must maintain for its accreditation as a specialty college; data collection for each specialty to evaluate what is appropriate for residency programs; and data collection to evaluate this Residency Training Program for renewal. It is important that all questions be answered accurately and completely, even if the answer to a specific question is not essential for a program's renewal.

Comments:

The total annual hospital case numbers were obtained from a search of our medical records system for 2017. The equine hospital cases is a sum of the Equine Medicine (391 cases) and Equine Emergency and Critical Care (464 cases) since the livestock resident participates in both of those services for 6 to 8 weeks per year in their training. For equine ambulatory visits, each animal seen is recorded as an individual record, even if more than one animal is seen at that specific site visit. The livestock resident may participate in equine ambulatory service on weeks when a LAIM clinician is supervising that service. Food & Fiber ambulatory visits are actual counts. For those 267 visits, examinations or procedures were performed on 6690 animals to give an average animal per visit count of 25. The total cases per visit was not entered since it is determined differently for Equine and Food & Fiber ambulatory visits.

Residents are required to enroll in a non-thesis Master of Science graduate degree program in the Department of Clinical Sciences. This program requires a minimum of 30 semester credits of coursework with at least 24 credits in didactic graded courses and a minimum of 12 credits at the graduate level. The graduate student must complete one 3 credit graduate level course in statistics/experimental design/epidemiology, 3 credits in a graduate level physiology course, an 4 semesters in the graduate seminar course where they will present at least two oral research presentations. LAIM residents are encouraged to also complete some or all of a 4 course series in Postgraduate Medicine.

Residents are simultaneously enrolled in courses while on clinical duty. Schedules are arranged to maximize the opportunity to participate in both.
